

CHAIRMAN'S MESSAGE

It is time for us to meet again. Under the Legal Profession Act 1976 (as amended) the term of the present Committee comes to an end. The activities of the Committee are set out in the Report.

During the last year there were changes, losses and unfinished business carried over from 1992. The only certain event is the continuing rise in membership of the K L Bar. The increase causes separate problems that this annual general meeting must address.

First on the changes. The much publicised amendments to the rules of court are finally in force with time table as to filing of affidavits; the restriction in seeking ex parte injunction; restriction in adducing further evidence etc. These changes have made practice more difficult. I believe that support and para legal staff are hard to come by. A legal firm is the last choice of a job-seeker! The profession will survive the difficulties with co-operation within the profession.

As to the losses, we have lost by death many members. One notable member must be mentioned. Our colleague, Karam Singh, a colourful personality, died in India in January 1994. The past minutes of the K L Bar, (and before 1992 the Selangor and Federal Territory Bar Committee) and the Malaysian Bar are final testimonies to his contributions to the cause and struggles of the Bar. The minutes of the last annual general meeting of the K L Bar show his immense interest in our affairs. Future general meetings of the Bar would not be the same again without him. To his family and the families of the others who died we record our deepest sympathies.

The unfinished business relates to the new disciplinary system enacted in 1992. Those amendments were found to be unworkable and the blame was laid at door of the Bar. Further amendments were made in 1993. Members were appointed to the Disciplinary Board. The disciplinary machinery is yet to take effect. Complaints since April 1992 are yet to be investigated. We can only hope that the Board would become functional and proceed to dispose the pending complaints.

Finally, as alluded to earlier, the increase in membership brings its own problems. The Committee would not be able to function on the present subscription of RM100.00. This sum was fixed for more than a decade ago. Staff and their salaries and emoluments have increased over the years. Rent for the present premises was recently increased. The K L Bar also intends to bring out its own newsletter. I trust that members would vote for an increase of the annual subscription to enable the Committee to function.

I thank all members for the co-operation they had extended to the Committee and me during the past year.

6. FINANCE

The financial position of the Committee is stable with a sum of RM161,352.03 in Fixed Deposit. Details of the financial position are as set out in the Audited Accounts ending 31-12-1993.

It is anticipated that expenditure for the coming year will increase and the Committee proposed to increase the annual subscription.

7. SUBSCRIPTION

The subscription for the year 1993 was fixed at RM100.00 at the 1st Annual General Meeting of the Kuala Lumpur Bar held on 5-3-1993.

According to the records kept by the Secretariat, up to 15-2-1994, 136 members are still in arrears of the 1993 subscription.

NUMBER OF MEMBERS

As at 15-2-1994 the Kuala Lumpur Bar has a total of 2594 members.

9. PETITIONS FOR ADMISSION

From 1-1-1993 to 31-12-1993, 555 Petitions were received by the Committee.

There were 541 members admitted to the Bar in Kuala Lumpur during the year 1993. According to the records maintained by the Secretariat out of the 541 members admitted 355 are in legal practice in Kuala Lumpur.

11. PUBLIC LECTURE ON AIDS

With the concern expressed over the issue of Aids in prison a public lecture on Aids entitled "Aids Behind Bars" was held on 9-7-1993. The lecture was delivered by Dr Jannie Chew who is an Aids Counselling Director.

12. OTHER MEETINGS

The "Book Prize" awarded by the Committee for the best mooter in the Bahasa Melayu section of the Annual Law Moot Competition 1993 was won by Ms Yeap Hong Imm.

14. BAR COMMITTEE DOCUMENT BOXES

The Committee had changed the wooden document boxes at both the KL High Court and Subordinate Courts Jalan Duta to aluminium ones with built-in-gadget to prevent pilferage of documents. In view of the change the annual rental had been increased to RM50.00 per box.

15. COMPULSORY INDEMNITY INSURANCE SCHEME

This Committee had received complaints from members on the compulsory insurance scheme. Representatives of the Committee had met the brokers. The answers did not provide solutions to the complaints of high premium. We had also inquired from another broker who is willing to provide top up cover on the same terms of cover as under compulsory scheme but at a reduced premium. This Committee feels that members, at least for the top up, should have alternative brokers. The brokers, we consulted, would write to the members direct with what they have to offer and members can negotiate directly with them.

These were well attended and the Committee expresses its thanks and appreciation to the speakers for these talks. This would ensure that the talks meet the needs of the practising Bar in Kuala Lumpur.

In addition we had also arranged a talk by the Honourable Mr Rajinder Sacher, the retired Chief Justice of the Delhi High Court on "Recent Developments in Public Interest Litigation" at the University of Malaya on (1-10-1993). The attendance was disappointing.

Finally the Committee had undertaken the task of producing a second volume of the Practice Notes/Directions since 1983 to 1993. The first volume, undertaken by the Selangor and FT Bar Committee, contained Practice Notes issued until 1982. The new volume is now in the final stages of editing and should be available soon at a small price.

4. ETHICS LECTURE PROGRAMME SUB-COMMITTEE

Lectures on Ethics and Etiquette were conducted regularly throughout 1993. These lectures consisting of 8 topics were spread out over one and half days (Fridays and Saturdays), when senior members of the Bar spoke to a number of pupils-in-Chambers on each occasion.

Attendance of the pupils was taken at each lecture. Pupils paid a fee of RM30.00 when the lectures were at the Bar Council Seminar Room and a fee of RM40.00 when the lectures were held at LPPKN, Jalan Raja Laut, Kuala Lumpur. The fees covered the cost of 3 teas, a lunch and rental at LPPKN.

The Ethics Lecture Programme Sub-Committee sent :-

LEGAL AID MANAGEMENT PANEL 5.

5.1 General

- (a) The Panel is glad to report some positive achievements for the past year. The talks given by members of the Legal Aid Panel at the Ethics Lectures has contributed to the increased participation. It is noted that many of the projects were oversubscribed by chambering volunteers.
- (b) On the minus side, it is regretted that a full-time lawyer/administrator has still not been approved by the Bar Council. The pace at which the activities can be implemented is very much dependent on this. appointment will free the Panel to devote their time to formulating and monitoring the implementation of policies. Presently, they are also bogged down to a large extent with the day to day management of the Centre.
- (c) There has been a 32% increase in the membership to 1523 volunteers. They handled a total of 1121 files constituting a 30/70% criminal and civil profile respectively. Advisory services were provided to 1114 clients.

5.2 Finance

A sum of RM210,908.00 was approved by the Bar Council Legal Aid Committee for the Centre's operation for the year 1993.

5.3 Activities/Projects

- (a) Emphasis was on literacy programmes for the year under review. This was possible because the court litigation/advisory programmes are now well in place and running on their own steam.
- A major literacy project was launched with NGOs. (b) planning/exploratory meeting was held to ascertain the requirements of NGOs. A subsequent programme was launched to cover care areas which were relevant to workings of all NGOs. This was well received. Course content included para legal training, human rights, rights in criminal law, the criminal justice system and The programme is now in its mid-term labour law. Participation included FOMCA. Tenaganita, Awam, Persatuan Sahabat Wanita, MTUC, Pink Triangle etc.
- (c) Speakers were also provided for the following seminars/workshops:-
 - (i) Tenaganita Migrants Workers Policies Implication/Responses 1993

Two speakers from LAC spoke on rights under labour law and rights under criminal/immigration law respectively.

(ii) Pink Triangle/Ikhlas

Two speakers participated in a forum on obscenity laws, law and homosexuality.

(iii) Tenaganita

Two speakers spoke to transexuals on their rights in law.

- (iv) Practice and procedure in Syariah Courts by Puan Kamar Ainiah.
- (d) The LAC participated in a Community Week at the Atria Shopping Centre. A legal clinic was held daily from 11:00 a.m. to 6:30 p.m. The good turnout of volunteers included the past President, YM Raja Aziz Addruse.

5.4 Ongoing Projects

(a) Pudu Jail Clinic is functioning at its normal capacity.
 Many chambering students have expressed their appreciation for the exposure given.

A CASA (a) Kajang Prison Clinic

Another milestone has been reached. The Ministry of Home Affairs has recently granted approval for the organisation of a similar clinic at Kajang Prison. The project is now in the able hands of Mr Jeya Mahesan.

(c) Syariah Clinic

The clinic is now open on Wednesdays and is being manned by 71 volunteers. The members were briefed on basic practice at the Syariah Courts by Cik Azalina and Cik Rubiah Jaffar.

(d) Chambering Students Programme

The programme is now into its 17th session. A review is being done to increase the efficacy of training provided in the programme.

5.5 Seminars

The Centre was also represented at the following seminars/workshops:-

5.6 Radio Talk

The LAC is now airborne on Radio Ibukota every alternate Wednesdays from 10:15 a.m. to 11:00 a.m. The Selangor Bar has apparently no objections to us broadcasting into the Klang Valley!

5.7 Forthcoming Projects

- (a) The Syariah Sub-Committee is in the midst of planning a literacy campaign and hopes it will be ready for implementation with the incoming term.
- (b) A Criminal Advocacy Course for volunteers is already in the pipeline. The Sub-Committee has obtained the services of experienced criminal practitioners for this programme. It is hoped the same will be videotaped for use by other LACs.

5.8 Projects that did not take off

- (a) The Duta Dock Brief could not be implemented. This was due to the lack of physical premises and more importantly, approval for the use of the same by the authorities. Efforts are still being made to proceed further.
- (b) The "Dial-A-Law" project did not materialise. The time and efforts of our volunteers were devoted to other projects.
- (c) The Chairman on behalf of the Panel expresses his thanks to all volunteers who have unstintingly given their services and who have withstood the brickbats, sometimes both from clients and employers (lawyers).
