#### **Civil Practice & Court Liaison Committee (CPCLC)**

- To engage with the Judiciary and other relevant stakeholders for the collective goal of improving the administration of justice;
- To set in place and/or improve procedures and systems to enhance members practice in the areas of civil practice;
- To foster solidarity among practitioners in relation to their practice in the Kuala Lumpur Courts;
- To deal with complaints and/or issues faced by members of the Kuala Lumpur Bar in relation to their practice in the Kuala Lumpur Courts and the Palace of Justice; and
- To encourage and focus on initiatives to help members expand and innovate their civil practice.

# **Corporate & Conveyancing Practice Committee (CCPC)**

- To identify and assist in resolving issues encountered by members of the Kuala Lumpur Bar in corporate and/or conveyancing practices, including matters related to the Land Offices / Registries, Stamp Duty Offices and the Companies Commission of Malaysia;
- To foster relationships and enhance communication amongst all parties and stakeholders involved in corporate and/or conveyancing practices;
- To strengthen the legal knowledge and expertise of Kuala Lumpur Bar members in corporate and/or conveyancing practices by organising seminars, workshops, conferences, training sessions and talks; and
- To collaborate with the Conveyancing Practice Committee and the Corporate and Commercial Law Committee of the Bar Council, the Selangor Bar Committee and the other State Bar Committees (as and when necessary) to achieve the above objectives.

# **Criminal Law Practice Committee (CLPC)**

- To engage and maintain continuous communication with the Kuala Lumpur Criminal Courts, the Attorney General's Chambers, enforcement authorities and other relevant stakeholders for the betterment of the administration of criminal justice;
- To set in place guidelines to enhance the practice of criminal law in the Kuala Lumpur Courts;
- To deal with complaints of members of the Kuala Lumpur Bar in relation to their criminal practice in the Kuala Lumpur Courts;
- To expend efforts to eradicate touting at the Kuala Lumpur Courts; and
- To expose and encourage young lawyers to participate in criminal practice by conducting and organising talks, seminars, workshops and criminal practice mentoring programme.

### **Gender Equality & Diversity Committee (GEDC)**

- To conduct Diversity & Inclusivity Training sessions for pupils;
- To carry out programmes to curb discrimination and harassment within the legal profession;
- To carry out focused awareness and sensitisation programmes on Gender Parity, Equality and Diversity;
- To promote mental health awareness and create more events to engage with members on this topic;
- To conduct outreach programs with external stakeholders and members of other state bars: and
- To conduct events with an aim of enabling further conversations on matters outside the realm of "professional skills.

## **Professional Development Committee (PDC)**

- To develop and implement professional development programmes for members of the Kuala Lumpur Bar. The PDC provides opportunities for members and pupils to strengthen their legal knowledge and stay updated on industry developments. These initiatives equip them with essential skills to navigate the challenges of a competitive legal profession;
- The PDC seeks to foster a culture of continuous learning and professional growth, supporting career advancement while serving as a platform for members to share expertise and exchange knowledge within the legal community;
- To develop training and public speaking skills for Kuala Lumpur Bar members interested in becoming speakers or trainers for professional development programmes, enhancing their professional practice; and
- The PDC will assist in organising programmes that enable members to obtain CPD points in compliance with the CPD Scheme.

#### **Pupils Welfare Committee (PWC)**

- To promote and protect the interest and welfare of pupils in the Kuala Lumpur Bar;
- To provide an avenue for pupils in the Kuala Lumpur Bar to foster camaraderie within and beyond the Bar;
- To provide a platform for pupils to effectively voice their concerns over any issue that may arise in their pupillage:
- To establish a system to enhance and improve the professional skills of pupils; and
- To establish channels of communications with law students by forming strategic partnerships with law schools.

#### **Sports Committee (SC)**

- To organise a variety of sporting activities aimed at promoting interaction and camaraderie among members of the Kuala Lumpur Bar, including flagship events such as the annual Kuala Lumpur Bar Run and the Kuala Lumpur Bar Futsal Tournament;

#### **Young Lawyers Committee (YLC)**
